Awards: Each category has medals and certificates for 1st, 2nd, and 3rd places.

Match rules:

Article 1: The **original** Rules and Regulations of the International Amateur Sambo Federation (FIAS) approved by XVII FIAS Congress (Nov'2006, Sofia, Bulgaria, are applied.
