1. Registration

Entry Fee (NO REFUNDS):

Sport and/or Combat:

- \$75 per participant (\$10 per additional category)

2. Each participant has to have a valid medical insurance, and present the insurance certificate to the Organizing Committee.

Weight Classes (weights are in Kilograms, multiply by 2.2 for weight in pounds):

Cadets (16 and younger): -46, -49, 53, -58, -64, -71, -79, -88, +88 kg

Adults (17 and older): -58, -64, -71, -79, -88, -98, +98 kg

Awards: Each category has medals and certificates for 1st, 2nd, and 3rd places.

Match rules:

Article 1: The Rules and Regulations of the International Amateur Sambo Federation (FIAS) will be applied. The blue and red Jackets and Sambo shoes are mandatory for all adults. In addition, **Chokes will be allowed**, if both competitors (and their coaches, if in Cadets division) agree.

Article 2: A minimum of two (**2**) competitors is needed in each weight/age class to be declared a champion and receive a medal.

Article 3: The Tournament Director reserves the right to apply the type of competition formula based on the number of participants in a weight/age category.

Cadets - 3 minutes.

Adults - 5 minutes.
