1. Registration

Entry Fee (NO REFUNDS):

Sport and/or Combat:

- \$80 per participant (\$0 per additional category)

Early Mail-In or Online Registration: \$75. All payments must be received no later than November 4th, 2022.

In-person Registration and Weigh-In (Saturday, Nov 5th 9:00-10:00am): \$80 at the tournament venue.

* Additional Weigh-Ins will be conducted by Certified AASF Coaches at their Clubs and submitted no later than 9pm on Friday, November 4th.

* Each participant must be in the possession of a valid form of ID and plays on his/her own risk.

* Each participant has to have a valid medical insurance, and present the certificate at the time of Registration

2. **Weight-Ins Categories** (weights are in Kilograms, multiply by 2.2 for weight in pounds):

Cadets (16 and younger): -46, -49, 53, -58, -64, -71, -79, -88, +88 kg

Adults (17 and older): -58, -64, -71, -79, -88, -98, +98 kg

3. **Uniform:** Athletes 17 years of age and above must have a blue and red sambo jacket, shorts, and sambo shoes. Modifications will be allowed for athletes below 17 years of age.

4. **Awards:** Each category has medals and certificates for 1st, 2nd, and 3rd places.

5. **Match rules:**

Article 1: For the Tournament, the age division of the participant is determined by a year he or she is born (regardless of the exact date).

Article 2: A photocopy of your photo ID must be presented with your registration.

Article 3: The **original** Rules and Regulations of the International Amateur Sambo Federation (FIAS) approved by FIAS Congress (March 20, 2020) are applied. The blue and red Jackets and Sambo (or wrestling) shoes are mandatory for athletes of 17 years of age and older. For a complete list of Sambo Competition Rules please visit our website at:

*In addition, **Chokes will be allowed**, if both competitors (and their coaches, if Cadets) agree.

Article 4: A minimum of two (**2**) competitors is needed in each weight/age class to be declared a champion and receive a medal.

Article 5: The Tournament Director reserves the right to apply the type of competition formula based on the number of participants in a weight/age category.

6. **Duration of Bouts:**

Cadets – 3 minutes.

Adults – 5 minutes
